

TERMS OF USE

1. These terms and conditions apply to you and you are bound by it if you play the National Lottery via our service, referred to as LottoShop.
2. LottoShop is an online lotto agent owned by an independent company and not affiliated to the National Lottery SA or Gidani, Should we become an affiliate of the National Lottery or Gidani, we will advise accordingly.
3. LottoShop provides an electronic platform for its members and non-members to some extent. Membership is required for certain services as LottoShop acts as an agent on behalf of its members for all valid plays on LottoShop platform.
4. We are not a lottery company, retailer of any lottery ticket and does not, nor does it purport to run a lottery, nor, sell lottery tickets, we are just an agent.
5. By registering with us, you agree to comply with these Terms and Conditions of Service (T&C).
6. You must be 18 years or older to play or claim a prize.
7. The onus is on you to check whether your ability to play Lotto online is legal in your country since we cannot restrict our presence to certain geographic region. Please do not hesitate to contact us if in doubt.
8. LottoShop reserves the right to change, amend or add new features to the services rendered and are also subject to these T&Cs without prior notice.
9. You will not conclude any agreement with us without registering as a member and by so registering you unconditionally and irrevocably consent to your use of all functionalities of the websites and all transactions concluded on it being subject to these T & C contained herein.
10. LottoShop does not make any representations or give any warranties, whether expressly, tacitly or implied, as to the operation of LottoShop, the information, content, materials and products that are included and available on LottoShop is sourced from the National Lottery, and shall not be liable for any damage of whatsoever nature arising or resulting from the use of or inability to use LottoShop or the information contained herein, including but not limited to direct, indirect, incidental, punitive and consequential damages. 13. As a member, you are obliged to:
 - Familiarize yourself with the current rules of the National Lottery in which you order lottery tickets through LottoShop
 - You have the necessary legal capacity to become a member of LottoShop and place legally binding orders for lottery tickets
 - You cannot hold LottoShop liable for any misinformation or misrepresentation of data on the LottoShop website.
 - The LottoShop website is merely an invitation to do business and is not an offer to contract.
 - You understand that we are simply an agent and not a Lottery company.

14. Every pay-out from LottoShop must comply with the Financial Intelligence Centre Act, 38 of 2001, otherwise known as FICA.
15. LottoShop servers will process all ticket purchase before daily cut off time on game days which is currently 18:00, you must then ensure you have purchased your ticket before the mentioned cut off time, LottoShop reserves the right to change the cut-off time without prior notice.
16. Certain part of LottoShop can be used without registration, by registering you afford yourself more features of the system.
17. Registration is completely free; we charge a R1.40 South African rand for every single transaction ticket.
